Polaris Makes Investment in Acquisition of 188 Room Tsujiki Ginza Hotel; Will Operate the Hotel Under its KOKO HOTEL Brand

April 30, 2021 Polaris Holdings Co., Ltd. (hereinafter "Polaris" or the "Company") announced today that it closed on its a coinvestment alongside Star Asia Group, the sponsor of Polaris, in a special purpose company (the "SPC") to acquire the trust beneficial interest in KOKO HOTEL Tsukiji Ginza located in Chuo-ku, Central Tokyo (the "Hotel"). Polaris will operate the hotel under a management contract with the Company's KOKO HOTELS Brand which is a subsidiary of Polaris. The Hotel is located 5-minute walk from Tsukiji Station on the Tokyo Metro Hibiya Line and a 10-minute walk from Higashi-ginza Station on the Tokyo Metro Hibiya Line and Toei Subway Asakusa Line. It is conveniently located near Tsukiji Fish Market, which is very popular destination with domestic and foreign tourists and is also only a short walk from the famous Ginza shopping district. The Hotel also provides easy transportation access to both Haneda Airport and Tokyo Big Sight and Ariake. Further development is expected in this area due to the redevelopment of the vacant Tsukiji Market site and the opening of New Tsukiji Station.

The average size of the Hotel's guest rooms is 20 m^2 which is quite spacious compared with most business hotels while more than 70% of the guest rooms can be used by three or more guests. The Hotel also has four meeting rooms and two restaurants which will allow the Hotel to be much more competitive in capturing both leisure and group travel demand.

Polaris expects to achieve an attractive investment return on its invested capital due to an increase in earnings from operating the Hotel as well as the potential for capital gain on future sale on the Hotel as the hospitality industry rebounds.
