Polaris Concludes New Lease Agreement for KOKO HOTEL Osaka Shinsekai

Polaris Holdings Co., Ltd. announced that its subsidiary Minacia Co., Ltd. (hereinafter referred to as "Minacia") which has been operating "KOKO HOTEL Osaka Shinsekai, has signed a new building lease agreement with the Hotel's new owner. This agreement changes the operating structure of the hotel, moving from a management contract to a lease contract that combines both fixed and variable rent payments.

1. Background leading to the execution

The Hotel has operated under a fee-based hotel management agreement, characterized by a low-risk, low-return profile. Following the change in ownership of the Hotel, Polaris Holdings discussed with the new owner and decided to enter into a New Lease Agreement, which combined both fixed and variable rents and offered a mid-risk, mid-return profile and with higher profitability and ensuring a longer-term operation opportunity compared with the existing management agreement.

The Hotel, located in the Shinsekai district of Osaka, one of the city's most popular tourist destinations, has consistently maintained high occupancy rates and room prices.

The Company expects stable performance going forward by capturing the continuing inbound and domestic tourism demand that is expected to remain steady even after the conclusion of EXPO 2025 Osaka, Kansai.
